ZYC MEMBERS DUES PAYMENT

Let me try to bring everyone up to speed on where we are in terms of current situation with the property. As I mentioned under "Commodores Comments" we are indeed here to stay. But not without some sacrifice. That sacrifice mostly attributing to increase in dues. The dues increase a necessity due to the fact that we, The Zanesville Yacht Club will be entering into a contract with a bank to borrow \$220,000 to purchase the majority percent of the property. With this sacrifice we hope to receive big rewards. By controlling the majority of shares of the property we will be able to proceed into the future with continued improvements and growth. More improvements to the clubhouse, upgrades to the docks, additional docks, etc, etc, We want to be able to do these improvements, continue to carry on as we have and obviously be able to pay the mortgage we will now acquire. Hence the reason again for the increase in dues to \$300.00 per membership. We know this is a big jump for everyone and have been asked by several if they can make payments. The trustees have come up with the following terms:

PAYMENT TERMS:

Dues \$300.00 + Tax \$21.00 = Total Due \$321.00

\$100.00 due by April 1st

\$221.00 balance due by June 1st

This gives our members 6 months to pay the total amount due and you can send in payments however you wish. For example, \$50.00 a month, \$25 every other week, it doesn't matter to us as long as you have \$100.00 paid by April 1st & balance by June 1st. (If prepaying for 2 years at \$535.00 same terms as above, \$100 by April 1st, balance of \$435 by June 1st))

DOCKAGE MUST BE PAID IN FULL BY APRIL 30TH TO SECURE YOUR SPACE.

SPECIAL NOTE: Charter Members have been given a \$100.00 discount making your dues \$200 + \$14 sales tax. Due date & terms same as above.

NEW MEMBERS THIS YEAR will also receive a promotional discount of \$200.00 initiation fee being waived. **NEW MEMEBRS THIS YEAR WILL PAY \$321.00 to join.** So tell anyone you know who may want to join. **THIS IS THE YEAR TO DO IT.**
